The purpose of these calls is to update OUW members about current legislative issues that could have an impact on United Ways and the other nonprofits. OUW seeks input from members to create a consistent and shared point of view on public policy issues relating to education, income and health so that we can speak with one voice. Our members help to determine each year's legislative priorities.

This orientation is open to any new executive director or CEO. OUW staff provides an overview of Ohio United Way including our mission and the benefits of membership. During the orientation, an experienced CEO joins to talk with new executives about the CEO's role in the community, United Way Worldwide reporting requirements and answer questions relating to annual United Way campaigns.

OUW provides new executives with the option to be mentored by experienced United Way executives from adjacent communities. These mentoring relationships help to accelerate the learning curve of new executives.

These are small group sessions. Participants share their community impact successes and challenges. You will receive feedback and suggestions from the facilitator and your peers. Participants from each United Way will identify several steps that will propel your community impact efforts forward with measurable outcomes.

This process helps to ensure that members and agencies have the opportunity to participate in the annual campaign for state employees.
